“We are happy to provide a long-term future for these iconic brands” declared Xavier Jouvét, Antalis Group Papers Director. “We are already working on relaunching these brands with the support of best-in-class suppliers for a renewed assortment with a focus on quality and service levels. In the meantime, we have also acquired the vast majority of the remaining finished goods of these brands. This additional stock, on top of the current inventory we already have in our warehouses, should allow us to respond to most of our customer demand in the coming months until the transition to new sourcing in Q1 2023. In countries where Antalis or other KPP Group distribution companies are not directly present, our plans are to continue to make these brands available through a network of distribution partners” he added.
